CHAPTER 1: RESEARCH PROPOSAL

1.1 Research Background

"Marital rape" is defined as sexual intercourse by the husband with his wife without her express consent. The husband and wife must be legally married and recognised as a married couple, having the same rights and obligations under the law^{1} . It can also be called as a spousal rape. This issue is controversial since it involves with the relationship of husband and wife in a matrimonial institution. For the record, in 2005 alone, as from the survey conducted by World Health Organization (WHO), more than 50% of women in Ethiopia, Bangladesh, Tanzania and Peru reported having been subjected to physical or sexual violence by intimate partners, with figures reaching a horrific numbers of 71% in rural Ethiopia². In Malaysia, as in the subject of rape, out of 133 sexual offenders imprisoned in Sungai Buloh and Kajang's prison, only 20 out of this 133 committed their sexual offence against the person who's unknown to them³. Additionally, by looking from the report made by Dr Norliza Chemi, 72.9% of rapists in Malaysia are those who are intimate and known to the victim⁴. Throughout the world, numbers of countries (104) had already criminalized such act and this includes Common Law countries such as Scotland and England⁵

Right before 2006/2007, Malaysia does not cover any provision regarding sexual domestic problems, as even in the Penal Code itself, provides the Exception
