

DURATION

ROLES & RESPONSIBILITE





EXPERIENCES

POLITICAL/ECONOMIC

• POLITICAL - Political Stability

Political stability also can affect Pos Digicert if any diversion happens. Pos Digicert did have a few collaborations with the government such as project MAMPU but if anything happens to the government, it can leave an impact to the project and company also. For instance, while the project is going on at the same time there is an election happening and the government changes, the project will get investigated by the new government to see the flow of the project from beginning until the end. They might investigate whether the company obtained and handled the project in a proper way. Other than that, some projects will be brought to the parliament to follow up with the status of the project and if the company did not do well, it can tarnish the image and revenue.

• ECONOMIC - Economic Conditions

Economic conditions provide information about the state of a country's or region's economy currently whether the economy is expanding or contracting as it is always fluctuating which business and economic cycles follow too (Gordon, 2023). A nation's economic circumstances are favorable and good during an expansion period, but vice versa during a recession phase (Gordon, 2023). By that means Pos Digicert revenue also can be fluctuating from year to year based on how our current economy is doing. Clients also will get affected by this as they are the one who will be spending and demanding digital certification services. Since there are only 4 companies that provide this service, Pos Digicert has to play smart in negotiating with their clients. If we lose them, then the profit will decrease.



SOCIAL/TECHNOLOGY

• SOCIAL - Consumers preference

Consumer preferences are very important for every business because if we can meet their preferences, perhaps they can stay loyal to our brand. First, every company needs to know who their target market is and how they prefer their services or products to be offered. The company must prioritize what their consumers' needs and must come out with services and products that can satisfy them. Consequently, it motivates the client who has been kept to act as a brand ambassador, promoting positive comments about your business and essentially offering free marketing services (Dutta, 2023). The more the services or products consumed by the consumers, the more profit they can generate.

TECHNOLOGY - Rapid technological changes

Throughout the years, it can be seen that technology keeps on evolving from time to time which makes it more advantageous than before. Currently, the AI system has been on top of their game where its function is to overcome human limitation in solving problems. That is why every industry must develop new strategies on how to keep up with the trend changing. However, it can be very challenging for the company to follow the trend as it needs a lot of energy, effort, training and cost. Since Pos Digicert services related to IT systems, they are giving their best in providing easiest and accessible applications or software to their customers also with higher security protection.



ENVIRONMENT/LEGAL

ENVIRONMENT - Limited resources


Facing this obstacle can weaken the strength of Pos Digicert in producing their services or products. They may have advanced in technology infrastructure and architecture but their rivalry will always try to one step ahead of them. Pos Digicert is not able to offer what their rivalry can offer to the clients which can turn their back from having any projects with Pos Digicert. Resource is not just limited to raw materials only, however it can involve skills, manpower or equipment that can restrain the company to move forward. In this case, Pos Digicert may not have certain skills or equipment that can help them in fulfilling their clients' requirements. Limited resources is something that can be controlled if Pos Digicert plans their strategy wisely.

• LEGAL - Compliance with law

As mentioned before, Pos Digicert's business involves personal information from clients and consumers. Compliance with the law set by the government is very important to ensure the business can run smoothly without any issues created in the future. Digital Signature Act 1997 (Act 562) is one of the laws that Pos Digicert has to comply with for a product called Digital Signature which makes it more legal and verified. However, if the government decided to make an amendment with the law, then the company must immediately change according to what has been decided. Whether the changes can be a good or bad one, the company has no rights to object and if the company refuses to do so, consequences are waiting ahead. It can be shown that any regulations or law made by the government cannot be taken lightly if the company still wants the business running the market. Changes in these laws can have significant implications for how the company manages and secures digital data.







STRENGTH 1

Advanced technology infrastructure and architecture

Architecture in technology can be called as a base which means from here how the company starts to build including creation, arrangement and maintenance of IT assets of the system for the company. According to Ameya (2023), knowing IT architecture is important because it helps companies match their IT resources to their goals, maximize productivity, guarantee scalability, and improve overall performance. Meanwhile, according to Indeed Editorial Team (2023), technology infrastructure where the companies use all the facilities includes the hardware, software, and networks to create, deliver, test, control and support IT services. In Pos Digicert, they are the first company inventing the digital certification, it means they already possessed this strength as they are the one who came out with this idea. They knew what kind of service they would be doing which by now there are few IT products that were produced by Pos Digicert. As of 2019, 92.5% of digital certificates in Malaysia have been issued by Pos Digicert. It can be seen that Pos Digicert has fully utilized this strength to the fullest where the employees know what to do in order to align with the company's goals.

RECOMMENDATION

Learning and development programs

Since technology keeps on evolving rapidly, the employee needs to catch up with the latest of changes. It requires them to update their skills to ensure it is on par with the newest update of technology which can improve the infrastructure of the company. Nowadays, e-learning would be the most convenient for the company to provide for their employees to learn and develop new skills. Sometimes, the employee already has a full on the plate which makes them unavailable to attend physical training and by implementing a learning management system, the company can track their progress. Learning management system function is software that can create, deliver and track training courses and programs. Through this system, the employers can deliver any material to the employees and are able to track employees' progress from time to time instead of going to training centers that need to be scheduled.

STRENGTH 2

Strong industry partnerships

In the world of business, having good partnership can bring great outcomes and help to the company. From this partnership, you can widen your image to other companies and make a connection with them. Perhaps, from this certain connection, other companies might recognize the achievement made by Pos Digicert which can attract their interest in investing in this company. Since Pos Digicert is doing service, the company managed to have a strong relationship in other sectors too such as technology, finance or retails. Not to forget, having a project with the government too can build a strong connection to the government if the company brings great outcomes. These collaborations can strengthen Pos Digicert's market position and provide access to a broader customer base.

RECOMMENDATION

Maintaining relationship with partnership for future business development

Though there are only 4 companies that provide certification authority (CA) service including Pos Digicert, bear in mind you can lose big projects to competitors if you are not able to fulfill their requirements. According to Adams (2023), it stated that 86% of consumers are more inclined to stick with a company in the future if they feel an "emotional connection" with it. There are few ways on how to build this emotion such as communicating effectively, exceeding expectations or being transparent. Communicating effectively when you can be open minded and respond to them frequently. Always asking for their update regarding the service or product. Other than that, Pos Digicert can set certain expectations toward the clients as a benchmark so the company can identify which part they can improve to exceed the expectations. It can help the company to stay in the right lane during running the project. Meanwhile, being transparent is when you are honest about how far you can deliver the outcomes to the clients. Do not lie to them if you are not completely sure as it is better to not give them high hope over the promise. Always get engaged with your clients to show our appreciation even if the project is already completed.

STRENGTH 3

Highly recognition

Getting recognised by other organizations can bring out the high quality and reputation in Pos Digicert. Since Pos Digicert services and products involve digital identities, they must have a license or recognition by certain companies to allow them run the business. There are 6 in total of recognitions that Pos Digicert is able to achieve including internationally. With these 6 recognitions, the client can put more trust and confidence towards them for new incoming projects. For example, TMMi Certified Level 3. Pos Digicert is the first Certification Authority in Malaysia to achieve TMMi Level 3. The certification indicates that Pos Digicert has the ability to run and deploy software development and maintenance projects according to rigorous international standards, methodologies, and procedures. Besides, Adobe Approved Trust List (AATL). This program enables millions of users worldwide to generate digital signatures that gain trust when the recipient opens the signed document using Adobe® Acrobat® or Acrobat® Reader® software.

RECOMMENDATION

• Collaboration or projects with big brand company

Pos digicert has the opportunity to go internationally with the strengths and opportunities that they have. They just need to plan a new strategy on how to attract clients from other countries instead of just depending on the government. Since they own a high recognition, perhaps they can convince more other companies with their new proposal to collaborate at the same time it can broaden the link. Pos Digicert can slowly start with **local big brand companies** and if they manage to bring excellent outcomes, they can start with international companies. Pos Digicert should start taking action in this as soon as possible, afraid if the competitors have begun. Though Pos Digicert had once got recognised in Malaysia for their roaming idea, it does not mean it can be maintained until forever as the competitors will always find ways on how to overtake.

WEAKNESS 1

Brand awareness

It has been the 25th year for Pos Digicert included this year, however, not many people have heard about this company as they are not familiar with it. Perhaps it can be because of the nature of the business that Pos Digicert provides, which are services that are rarely shown to the public even though the public are using it. It is just that they do not know who is behind the curtain that provides the services. Another case is low brand awareness and marketing in the market. It can be seen that Pos Digicert does not have a good strategy in awareness and marketing as up until now if Pos Digicert are being mentioned to the public, they will ask what this company does. Surprisingly, when we called candidates about the interview, some of them were clueless when we mentioned the name of the company. It is clearly shown that Pos Digicert brand recognition is limited due to their marketing strategy. They may rarely promote their brand to the public by letting them know that services that they are using might come from Pos Digicert. This can be a challenge for them in competing with more established players or attracting new clients.

RECOMMENDATION

Increase brand awareness with latest technology

In order to maintain the business still running in the market, Pos Digicert has to increase their level of marketing in promoting their brand. Depending on the project or collaboration that they are currently running right now is not enough to promote the brand. As for now, not many people are aware of the name of "Pos Digicert" because they rarely promote their brand publicly. Involvement in CSR (Corporate Social Responsibility) can help promote a positive brand image of the company to the public. According to Fernando (2023), it stated that practicing CSR can operate in a way that benefits society and the environment rather than detracting from them. Introducing products that are environmentally friendly such as using renewable energy sources with upgrade functions can attract more clients. Besides, they should participate in exhibitions as this event can help the company to be more exposed to the outsider. With products that are equipped with latest technology, the companies or clients also would be interested to invest or buy the products.

WEAKNESS 2

Narrow-scoped industry

Relying on a small number of key customers can be both profitable and precarious, particularly when the demands from these customers are on the rise as mentioned by Goeldner (2021). If the company starts to increase in facilities, payroll or other infrastructure to support key clients, it is crucial to consider the potential consequences if this client is lost or experiences a downturn in business (Goeldner, 2021). If a significant portion of Pos Digicert's revenue comes from a small number of clients, the company could be at risk if it loses any key clients or if they reduce their spending. Meaning, if the clients decide to back off, so do your profit. This can be one of their main weaknesses as it can leave a huge impact to the company especially in this state of economy. If Pos Digicert did not manage to fulfill their needs or comply with the conditions, it can put the company at risk that the client can find a substitute at any time.

RECOMMENDATION

Create new product or service solely for society's use

Since Pos Digicert is legal to produce digital certifications, creating new products or services for the whole society in Malaysia would be nice too. Currently, Pos Digicert have done projects if only their proposal is accepted by the clients. Otherwise, there will be no projects for Pos Digicert. Pos Digicert needs to create something which can be very useful and accessible to the society as now everyone would prefer things to get done through online platforms. For instance, **create one application for an identity card.** This application allows the society to use their digital identity card if physical identity card is not present. It is almost the same as a tax and license application. However, Pos Digicert needs to strengthen their cybersecurity as it is involved with personal information and verifying the identity card from "Jabatan Pendaftaran Negara" before proceeding the registration. This can be their competitive advantage and gain more revenue instead depending only from the projects.

WEAKNESS 3

Subject to regulations

As Pos Digicert's services involve personal data from clients and consumers, the company must comply with government's rules and regulations. They cannot simply make their own as personal data considered as private and confidential which consent from the owners is required. In fact, the company also cannot just simply ask for personal information without approval from the government. Because of that, rules and regulations were made for this and Pos Digicert must follow if they want to prevent any issues further. This can be considered a weakness because we have no rights in changing the rules and regulations and if there were any changes made, the company must follow. Whether the changes can bring disadvantages to the company and may affect projects or clients' need, Pos Digicert must follow without any objections. For example, digital signature is part of products from Pos Digicert where it complies with Digital Signature Act 1997 (Act 562).

RECOMMENDATION

Robust compliance monitoring and reporting

Robust compliance monitoring and reporting entail the establishment of systematic processes and mechanisms to oversee and track compliance-related activities within an organization. Pos Digicert needs to set up **structured procedures** for monitoring various aspects of compliance, including adherence to regulatory standards, internal policies, and industry best practices. Before the employees proceed with anything that is related to regulations, they need to go through the person in charge of monitoring to ensure it is in compliance with the law. The process can be continued if only they get approval. This is important because some companies did not alert with amendment of the law that has been made by the government and if they break the law, action will be taken immediately.

OPPORTUNITY 1

Technological advancement

Pos Digicert services was involved with technology as they provided digital certificates and digital signatures. Digital can be described as electronic devices that create, store, and process data using discrete numbers, usually zero and one (Rouse, 2023). With this opportunity, it has contributed profit to the company especially during Pandemic Covid-19. Since certain companies allowed their employees to work from home during Movement Control Order (MCO), services and products by Pos Digicert can be accessible even without meeting physically. In addition, SSM is also one of clients that use Pos Digicert's services which is Digitally Certified True Copy (DCTC). Those certificates received by the members who register for their SSM will have a QR code and serial number to ensure the verification of the certificates. In simple words, these products cannot be falsified or copied. E-filing for LHDN also is part of the product by Pos Digicert where you can submit the form in digital form instead of walk-in and hand in physical form. These products are at an advanced level as it is more modern in this era.

RECOMMENDATION

Produce more products and services align with trend - environment sustainable

Pos Digicert has to come out with more accessible and friendly-user products or services with less bugs whether through smartphone or laptop. As for now, Pos Digicert has created many applications and web designs for consumers to use, however, remember that everything technology or systems has its own loophole. That is why the company must plan a new strategy on how to cover the loophole, without damaging the current quality of services and products. In order to achieve these, Pos Digicert can focus on producing services or products that are **environmentally sustainable.** Stated by Indeed Editorial Team (2023), environmental sustainability often revolves around managing the utilization of natural resources in relation to their availability, aiming for a balance. Nowadays, people are more interested in go-green products as it has less pollution and since using software can contribute to greenhouse gas emission (GHG), this approach helps to prevent. Pos Digicert can use renewable energy or purchase solar panels.

OPPORTUNITY 2

Global expansion

At this point, Pos Digicert has come up with a new initiative where digital certificate storage medium can be kept by roaming certification. Roaming is when a wireless network service extends outside the registered home network location (Rouse, 2023). Previously, they only used physical types to keep the digital certificate such as token or smart card, however, by having roaming it will be much easier and accessible as you do not have to present the physical items. Pos Digicert grabs this opportunity that comes with high risk as there will be flawlessness and criticism towards the service as it is something new. Mentioned by COO itself, when they first introduced this service, people were criticized about it but now it has been recognized by the whole Malaysia. With businesses becoming more global, there is an opportunity for Pos Digicert to expand its services internationally and cater to the growing demand for secure digital transactions on a global scale.

RECOMMENDATION

Expand into international market

As mentioned before, with the recognition that Pos Digicert possessed currently, they can broaden their business internationally. Opening up new markets and taking advantage of cost savings are just two of the many opportunities that come with going global (Ziemba, 2023). In addition, having projects with the government can be advantageous for the company. The reason why is if the company did well with the project, perhaps it can attract companies from other countries too. To start business internationally, Pos Digicert can use cross-cultural management. Cross-cultural management involves the skill of identifying, understanding, and navigating cultural variations within the realm of business mentioned by TimesPro (2023). It means that Pos Digicert must do some research to understand and learn the culture of that country. This is to ensure that Pos Digicert did not violate any forbidden rules or be disrespectful to them in any way possible. If Pos Digicert is able to expand the business into the international market, they can generate more revenue and more vacancies can be given to unemployed people.

THREAT 1

Intense rivalry

In the world of business, one thing we have to remember is there will always be competitors who try to be on the top. Each of them will bring out their best weapon to attract the client's interest and fulfill their needs. Same goes for Pos Digicert. This can be their main threat as other competitors are more well-known and their brand recognition has reached globally for a long time. Example, MSC Trustgate.Com Sdn Bhd, TM Technology Services Sdn Bhd and Raffcomm Technologies Sdn Bhd are competitors for Pos Digicert. These companies can improve the next service or product that we have come out with which will be a risk for Pos Digicert as the client will be more convinced with competitors' ideas. Other than that, it is kinda hard for Pos Digicert to approach other powerful clients with our products and services as these competitors already stand out and are more convincing for clients to invest in their companies. Although Pos Digicert is slowly getting known globally, that does not guarantee their current position in the market as these competitors at any time can overpass as they already have strong partnerships with other powerful clients.

RECOMMENDATION

• Collaborate with rivalry for brand recognition

This strategy is a bit hard to get done and might also be the last choice but the outcomes will bring a great impact for both companies. This collaboration also can bring more benefits such as brand recognition and generate revenue. Both companies can provide **their specialty and combine** to create something new that leads to competitive advantage. During Research and Development (R&D), Pos Digicert can use their specialty in technical areas while the competitors can provide their specialty in information technology (IT) skills. From this, they can exchange a few knowledge that can be applied in the company. Pos Digicert should be bold in taking a risk if they want to go further in this business and try something new because who knows with this collaboration, more incoming projects will be handled. Mentioned by Garvie (2022), an organization's ability to foster collaboration among its staff members enhances its ability to solve problems both internally and externally. It can be seen that both companies and employees are able to gain benefits from this collaboration instead of handling solely with average outcomes.

THREAT 2

Competitors' service and offering

Post-service is when other companies can provide what we do not have in our products or services. This can be a crucial threat as what they offer to the clients can fulfill all their needs but we are not able to do so. This can be caused by limited resources, skills, or technology which create restraint for Pos Digicert to invent things that other companies are capable of doing. If this happens, it can decrease their faith in us and they will probably start looking for other companies that can offer them. Even though we only have 3 competitors for now, each of these companies have their own characteristics that others would not be able to imitate. We may be providing the same products and services but there must be something else to differentiate the specialty of each company.

RECOMMENDATION

· Overpower rivalry's service and offering

Another way to overcome the threats is by taking advantage of the strengths that the company has. As for Pos Digicert, they have strength in advanced technology infrastructure and architecture which allow them to produce more advanced service or products than previously. Pos Digicert can improve the lack based on previous mistakes to identify which part they can or need to improve. Analyzing feedback received from customers can be one of the ways Pos Digicert can take to identify the issues of services or products. From that improvement also, Pos Digicert is able to offer the same thing as competitors offer to their clients. Which means, they can attract more clients with more advantageous services and products. It can be a flop for the first time but if Pos Digicert is able to handle the situation excellently then the outcomes will be outstanding. Government interventions


