ABSTRACT

Waqf is Islamic endowment of property that use for charitable and religious event and that waqf cannot claim back by owner or their descendant after put that property under waqf. Nowadays, technology becomes more advanced and everything can be solved only by click in fingertips. And online waqf awareness was created in order to help people who want to make waqf without waste their time and This research explores the determinants online waqf awareness among Segamat residents. This research will explain the relationship between online waqf awareness with perceived of usefulness, perceived ease of use, perceived of religiosity and amount of information. Malaysia already promoted online waqf through Yayasan Waqaf Malaysia on 23 July 2008 and there are two ways in cash waqf which is with scheme or without scheme. This study highlighted the online waqf for this study and under category without scheme which is need to pay through online("Portal Rasmi Yayasan Waqaf Malaysia - Cara Berwakaf Tunai cara berwakaf," 2019). This research had been used IBM Statistic Package for Social Science (SPSS) to analysed the result. This research also used simple random sampling where the total amount 173 questionnaire had been distributed among Segamat resident. Furthermore, the result also been analysed by using frequency, descriptive, reliability, correlation and regression analysis. This study found perceived of usefulness, perceived ease of use and amount of information, except perceived of religiosity not significant towards online waqf awareness.
