## The Inaugural Audit Visit by the Ethics Review **Committee Panel Auditor** (EAP) from UiTM to the **Faculty of Education Ethics Review Committees**

The ERC Audit Panel, nominated by the Research Ethics Committee and appointed by the Deputy Vice-Chancellor, conducted an audit on the FERC Faculty of Medicine.

On June 4-5, 2024, Assoc. Prof. Dr. Salmi Razali from the Faculty of Medicine led the ERC Panel audit team. The team included a secretary, Assoc. Prof. Dr. Norziaton Ismail Khan from the Faculty of Accountancy, and three audit panels: Assoc. Prof. Dr. Suraya Abdul Razak from the Faculty of Medicine, Assoc. Prof. Dr. Amal Hayati Ishak from the Academy of Contemporary Islamic Studies, and Dr. Suhana Aiman from the Faculty of Sports Science and Recreation. Additionally, the team had two secretariats from the Research Management Centre, Assoc. Prof. Dr. Khasnur Abd Malek and ChM. Muhammad Hisyam Jamari, along with an observer, Emeritus Prof. Dato' Dr. Raymond Azman Ali, Chairperson of the Research Ethics Committee, UiTM.

Assoc. Prof. Dr. Mohd Khairezan Rahmat, Deputy Dean of Research and Innovation of the Faculty of Education, welcomed the visit. Other key attendees included Dr. Ahmad Fahim Zulkifli, Chairperson of the Faculty of Education ERC; Zulfa Zainal Abidin, Senior Assistant Registrar (Academic Affairs & Industry Linkages) of the Faculty of Education; Dr. Ani Mazlina Dewi Mohamed, a member of the Faculty of Education ERC; Mr. Cheong Tau Han, Coordinator for Infrastructure and Infostructure. The audit visit began with an opening presentation by Assoc. Prof. Dr. Mohd Khairezan Rahmat. followed by a presentation from Assoc. Prof. Dr. Salmi Razali.
