
## International Collaboration Teaching with Universitas Muhammadiyah Malang (UMM), Indonesia

A memorandum of understanding is an agreement between two or more parties outlined in a formal document. It is not necessarily legally binding, which depends on the signatories' intent and the language in the agreement but signals the willingness of the parties to move forward with a contract. A memorandum of understanding, or MOU, is a nonbinding agreement that states each party's intentions to act, conduct a business transaction, or form a new partnership. This type of agreement may also be referred to as a letter of intent (LOI) or memorandum of agreement (MOA). MOA are legally binding documents and serve to formalize the understanding between the parties involved, providing a framework for cooperation and collaboration.

They are commonly used in various sectors, including business, government, education, and non-profit organizations. Therefore, 20 January 2023, MoA and MoU between Universiti Teknologi Mara and Universitas Muhammadiyah Malang(UMM) has been signed, with UiTM Penang Branch Rector Prof. Ir. Dr. H. Ahmad Rashidy bin Razali and Prof. Dr. Fauzan From UMM.

Based on this MoU and MoA, on November 7, 2023 @ Tuesday, at the Smart Classroom at UiTM Pulau Pinang Branch, Bartam Campus, an international collaboration teaching took place with Muhammadiyah University Malang, Indonesia for the specific code NUR310 (Community in Nursing). Collaborative teaching, also known as co-teaching, involves educators working together to plan, deliver, and assess instruction for a group of students. This approach has several important benefits, contributing to a more inclusive and effective learning environment.



It is Collaborative Teaching Models 2: Delivery Collaboration Between Countries (Universities) where the project leader is Dr. Rusnani Ab Latif. The invited guest lecture is Dr. Yoyok Bekti Prasetyo, M.Kep.,Sp.Kom gave a lecture on "Maternal health care based on community health nursing". This academic activity is a projection from the Memorandum of Agreement (MoA) from the Memorandum of Understanding (MoU). According to Dr. Yoyok explained that the Mother Mortality Rate (MMR) in Indonesia is much higher than in Malaysia. The 2020 MMR data in Indonesia is still estimated at 173/100,000 live births, while in Malaysia in the same year 25/100,000 live births. Meanwhile, the world target in the parameters of the Sustainable Development Goals (SDGs) in 2030 is 70 deaths/100,000 live births. MMR is an important health indicator to describe the well-being and health of women, especially during the perinatal period (antenatal, childbirth, and postnatal). He emphasized that antenatal health care during pregnancy is very important to avoid risks that can cause death among mothers, especially for cases such as Post Partum Haemorrhage (PPH). The lecture ended with a question-and-answer session for 15 minutes.

This collaborative teaching was continued by lecture given by Dr Heny Dwi Susanti, with the topic "Skill of Nursing Management and Leader". According to Dr. Henny leadership styles are different approaches that leaders use to influence and guide their followers. Understanding one's own leadership style is important because it can help leaders better understand their strengths and weaknesses. There are three types of leadership styles namely, first autocratic leadership where the leader makes decisions independently and without input from their followers. This style may be effective in situations where quick decisions are needed, such as in emergency situations or when a clear chain of command is required. Second, bureaucratic leadership is a style where leaders make decisions based on established procedures and rules. This style may be effective in situations where consistency is very important. In situations where order is required, such as in government or large corporations, this style has its own benefits.

Third, democratic leadership is a style in which leaders involve their followers in the decision-making process. This style may be effective in situations where creativity and collaboration are required, such as in a team or in a business where innovation is important. A democratic leadership style can help motivate and engage followers, because they feel they have a voice in decisions that affect them. It also allows leaders to gather the input and perspectives of those under them to make better decisions. The teaching session ends with a question-and-answer session and giving prizes to students who can answer the questions asked by the speaker.
