



STRENGTHS

WEAKNESSES

The Project Development Division of IRDA faces challenges in its operations, including dependence on external funding and government aid. While federal support is a very valuable asset, too much reliance on it may jeopardize operational flexibility especially during periods of economic downturn or changes in national priorities. Such dependence may delay project implementation in case there are any delays in providing funds or requisite approvals.

An additional constraint is the reluctance of senior staff in adopting new tools and technology. For example, some staff would prefer to work with traditional methods rather than modern applications such as Canva, which helps simplify processes such as design and content creation. This unwillingness to embrace change may bind the hands of the department in extracting the full potential benefits that come with innovation and modern workflows leading to impacts in productivity and integration with industry best practices.

Lastly, IRDA faces challenges in talent retention and skills development. While the division gives priority to capacity building, competition from private sectors that offer more competitive packages may result in losing the skilled staff. In addition, the rapid pace of technological and practice changes in project development requires constant upskilling, which can be resource and time intensive. Addressing these weaknesses is important for the continued effectiveness of IRDA in driving regional development.

OPPORTUNITY

Similarly, the Project Development Division of IRDA has wide opportunities to expand its influence in the area of sustainable development initiatives. With the increasing global emphasis on green infrastructure and renewable energy, IRDA can position itself as a leader in eco-friendly project planning. The division should strive to attract environmentally conscious investors by incorporating smart city technologies and sustainable practices into its projects, which would fall in line with international development trends.

IRDA will also be able to develop partnerships with private and international stakeholders. Its strategic location next to Singapore provides a perfect platform for cross-border collaborations, especially in the technology, logistics, and financial sectors. The global firms can be engaged through PPPs, bringing expertise, funding, and innovation that accelerates the delivery of impactful projects.

Furthermore, the current wave of digital transformation comes as an opportunity for the modernization of IRDA operations. The division has opportunities in increasing its efficiency and effectiveness level at each point in the decision and workflow processes through GeoBIM tools by adopting cloud-based project management systems. Continuing education of staff will, therefore, enhance its workforce. Such opportunities will further cement IRDA's position as a pivotal facilitator in sustainable and innovative development for Iskandar Malaysia.

THREATS

The Project Development Division of the Iskandar Regional Development Authority (IRDA) is threatened by economic uncertainty and possible changes in policies. Fluctuations in the global and national economy, such as recession or inflation, may cause a reduction in investments and thus delay funding for the projects. Changes in government policies, priorities, or leadership may also shift the focus from ongoing initiatives, affecting continuity and execution timeliness for the projects.

Another major challenge will be the increased competition brought about by other regional development authorities and private developers. Other regions may offer better incentives or fast-track approval processes that could attract potential investors from Iskandar Malaysia. This may have a very negative effect on IRDA's ability to secure financing and establish partnerships for its projects, possibly limiting its growth and influence.

The third and final major challenge is the rapid technological change. While they offer innovation opportunities, failure to keep up with emerging tools and trends may decrease the competitiveness of IRDA. Reluctance among the older staff to adopt new technologies may hamper the modernization efforts in the division. Again, risks related to cybersecurity and possible data breaches could compromise the integrity of information related to projects and the confidence of stakeholders in those projects. IRDA has to overcome these challenges to remain relevant and at the forefront of the project development arena.

CONCLUSION

In conclusion, my internship at the Iskandar Regional Development Authority profoundly impacted my professional development, granting exposure that substantially broadened my skillset and understanding of project coordination. Across twenty-four weeks, I actively contributed to diverse initiatives including revising the newsletter publication and designing promotional materials, experiences allowing me to apply organizational and technological abilities within real-world constraints. The encouraging atmosphere nurtured by supervisors and coworkers fostered beneficial learning, offering insights into operationalizing plans and administering systems.




