INTRODUCTION

In today's world, there are many issues of transplant, organ donation and transgender. Islam offers a deep and complex viewpoint on a wide range of topics, such as gender identity, organ transplants, and medical advancements. Islam typically supports organ transplantation as long as it is carried out ethically and meets a legitimate medical need. Most Islamic scholars concur that saving a human life is more important than many other factors. Organ transplants are frequently justified by the "Maqasid al-Shariah" (preservation of life) concept, provided that the organs are procured and transplanted via morally and legally acceptable methods. Numerous fatwas, or religious decrees, promoting organ donation have been issued by Islamic scholars and organisations. These decisions emphasise the value of preserving lives and providing aid to those in need. Nevertheless, different schools of thought may disagree in the precise details and decisions. Islam, on the other hand, promotes charitable giving, compassion, and aiding those in need. Many Islamic scholars see organ donation as a constructive approach to uphold these beliefs. Organ donation should be done to save lives rather than for financial benefit, and consent from the donor and their family is thought to be essential. Some academics think that a donation is acceptable as long as it doesn't harm the giver living or deceased and it doesn't go against Islamic law. Though opinions may vary, people are urged to consult competent religious authorities for advice. Furthermore, Islam includes numerous traditions regarding gender roles, just like many other religions. In Islamic discourse, the problem of transgender individuals is a complicated and developing one. Opinions on transgender matters differ throughout Islamic groups and experts, hence there is no one Islamic position on the matter. While some academics contend that gender identity is a fixed, divinely-given characteristic, others acknowledge the difficulties transgender people confront and call for sympathy, acceptance, and assistance. There is a lot of discussion about this subject in the Muslim world, and opinions differ. Considering their cultural background and unique circumstances, Muslims frequently go to their local religious authorities or experts for help in all these topics. Like any major religion, Islam covers a wide spectrum of viewpoints, and people may interpret its teachings differently depending on their understanding and experiences. This is a crucial point to keep in mind.
