This Industrial Training Report, which is written for the MGT666, is divided into two sections. The first section provides information about the internship company, Pejabat Daerah dan Tanah Seberang Perai Tengah, including its overview and specifics. Located in Penang, Malaysia's Seberang Perai Tengah district, it is a governmental administrative entity. The research and data analysis on The Effects of Public Spending on Economic Growth in Malaysia comprise the second section. The objective of this study is to examine the relationship of public spending, inflation, interest rate, and public debt with economic growth in Malaysia. This study makes use of annual data as well as secondary data from online and historical sources by examining data from Statista, the World Bank, and the International Monetary Fund (IMF) between 1989 to 2023. The data is assessed using EViews, a feature-rich statistical, forecasting, and econometrics application. According to the study, the findings of this study suggest that public spending (PS) and also interest rates (IR) negatively and significantly affect economic growth, and public debt (PD) positively and significantly influences economic growth in Malaysia. Meanwhile, inflation (INF) results in an insignificant relationship with economic growth. The end of the report offers recommendations on how to enhance future research in this area so that more conclusive findings can be made.

Company's name, location and background

Pejabat Daerah dan Tanah Seberang Perai Tengah is the primary catalyst of the district's development in the Seberang Perai Region and located in the middle of the Penang Industrial Development Zone, particularly in the Seberang Perai Region, and is generally located in the middle of the Peninsula's North Main Development Zone corridor, either from the North-South or East-West perspective of the Peninsula which addresses at No. 61,63,65,67,71 dan 73, Jalan Perda Utara, Bandar Perda, 14000 Bukit Mertajam, Pulau Pinang. The district's land administration, revenue collection, development control, public services, and emergency preparedness are all under the direction of the Pejabat Daerah dan Tanah Seberang Perai Tengah (PDTSTPT). With 422,990 residents as of 2020, Seberang Perai Tengah is the third-largest district in Penang, spanning an area of 236,796 square kilometres. This multiracial and multiethnic population is spread throughout 21 mukims. Two cities, Bandar Perai and Bandar Bukit Mertajam, are also included in the district. They have been operating in a temporary office while the exact office is undergoing renovations.
