The Islamic banking sector is experiencing rapid growth and is projected to reach a market value of USD 7.7 trillion by 2033. This expansion highlights the urgent need for accessible educational tools to improve understanding of complex Shariah-compliant financial contracts. Traditional methods, such as textbooks and lectures, often lack the engagement and practicality needed to equip learners effectively. To address this gap, i-AgadQuest was developed as an interactive, gamified learning platform designed to simplify Islamic banking concepts for students, professionals, and the public. 


Table 1.: Steps for using *i-AqadQuest*




To begin, users can access the game by clicking on the provided link, scanning the QR code, or entering the entry code on the ZEP Quiz platform. Logging into an account is not required to participate in the game.



After entering the game, players will see the *i-AqadQuest* map displayed on their screen, which serves as their starting point.





By clicking the "Profile" button, they can customize their avatar and choose a nickname according to their preferences.



The game begins once players are transformed into animal characters. To return to their original avatar, they must complete 20 questions on Islamic banking contracts by moving through giant carrots.





If they choose the correct answer, they can proceed to another question.


