## 1.1 INTRODUCTION AND ORGANIZATION BACKGROUND

Kompleks Islam Putrajaya (KIP), which is situated in Putrajaya's Precinct 3, was constructed across a 2.21-hectare plot, and finished in August 2016. The four building blocks that make up the KIP are furnished with a variety of amenities. Built on the foundation of stunning modern urban architecture that harmonises traditional Islamic architecture with contemporary style. The goal of the KIP building concept was to create a more spacious and pleasant workplace. In every key region, there are also accessible facilities for the disabled.

This building consists of four blocks namely by Block A, B, C and D. Under the Prime Minister's Department's Religious Affairs portfolio, nine religious agencies are housed in this building. A bridge located on the second floor of each block provided as to connect the blocks A, C, and D. There is an underground auditorium in this building that can accommodate roughly up to 773 people at a time.

Kompleks Islam Putrajaya is fully owned by Lembaga Tabung Haji. The building of Kompleks Islam Putrajaya is maintained by a subsidiary company of Tabung Haji Properties (THP) Sdn. Bhd. called Tabung Haji Universal Builders (THUB) which offers integrated facilities management services starting from January 2016. THUB oversees managing and maintaining every service that is offered within the building, including those provided by subcontractors.
