1.0 INTODUCTION

However, in spite of closing the gap on the social media front, in electoral terms the BN's result slid further in 2013 compared to 2008. In General election 2013, Barisan Nasional win 133 seats compared to opposition party Pakatan Rakyat they win 89 seats. It is the worst electoral performance by Barisan Nasional since 1969. Before general election 2013 which is general election 2008, BN wins 140 seats and Pakatan Rakyat win 82 seats
