## Organizing the 17th IUCN Academy Of Environmental Law Colloquium 2019

On 5 - 9 August 2019, UiTMLaw, through its Centre of Environmental Law, Governance and Policy (CeIGOP) hosted the 17th IUCN Academy of Environmental Law Colloquium 2019 together with the IUCN Academy of Environmental Law. The IUCN Academy of Environmental Law is an international network of approximately 200 environmental law faculties and research centres from 60 countries. The theme chosen for the 17th IUCN Academy of Environmental Law Colloquium 2019, is 'Achieving Sustainable Development Goals (SDGs): Law as Part of the Solution' to enable both established and emerging scholars in environmental law and other related disciplines to contribute in addressing the common and different needs of societies. The Colloquium was held over for 5 days at the Asian International Arbitration Centre (AIAC), Kuala Lumpur. The opening address for the plenary session was by YBrs. Pn Nor Aziah Binti Jaafar, Director, Department of Environment, Federal Territory Kuala Lumpur followed by the welcome speech by YBhg. Prof. Dato' Dr. Rahmat Mohamad, Deputy Vice Chancellor ( Industry, Community, Alumni ( ICAN ), Universiti Teknologi MARA. The Keynote Speaker was Professor Elizabeth Kirk, who is also the Chair of the IUCN Academy of Environmental Law.

Among the objectives of the Colloquium were :

- i) preservation of the environment
- ii) reducing pollution
- iii) preparing the country to address climate change through adaptation and mitigation.

The 5 day Colloquium had successfully highlighted the issues and challenges as well as opportunities related to the importance of law to the successful achievement and implementation of the SDGs.



The streams chosen were :

- i) Crisis Response
- ii) Environmental Justice
- iii) Climate Change Energy Nexus
- iv) Deforestation,
- v) Food Production and Security,
- vi) Sustainable Waste Management, and
- vii) Clean Water Infrastructure

UiTMLaw also hosted the Tony Oposa Intergenerational Moot Court, bringing students and scholars together in a simulation of a court proceeding before the International Court of Justice; addressing the questions of indigenous people rights and global warming. The International Malaysian Society for Maritime Law (IMSML) is a non-profit organisation dedicated to promoting Human Resources and maritime related policies in Malaysia, in order to keep Malaysia competitive internationally. Assoc. Prof. Dr. Irwin UJ Ooi (UiTMLaw's Head of Advocacy and Dispute Resolution) has been a member since its inception. Recently, Dr. Ooi was invited to speak at its Certificate Course in Maritime Law, at Double Tree, Hilton, JB. The course ran from 19-21 August 2019, and was partially subsidised by the Malaysian Government. Dr. Ooi was a Course Director together with Shipping Law stalwarts Jeremy Joseph (Joseph and Partners), Wan Hilwanie Ariff (Ariff and Co), Clive Navin (Christopher Lee Ong) and Trishlea Ann (Skrine). Dr. Ooi's focus for the course was charterparties and bills of lading. Participants attending the course were from various sectors of the maritime industry from ports, to logistics companies, shipowners and regulatory authorities.

#### ARISE+ Meets Stakeholders in Phnom Penh

Earlier this year, Assoc. Prof. Dr. Irwin UJ Ooi was appointed by the European Union to aid its technical assistance arm to South East Asia (ARISE+), help ASEAN Member States implement the ASEAN Framework Agreement on Multimodal Transport 2005 (AFAMT2005). Dr. Ooi and Team Leader, Glyn Evans, had a consultation session with various industry stakeholders over two days on 10-11 June 2019. The session was hosted by the Ministry of Public Works and Transport. During the session, Dr. Ooi also presented and discussed with stakeholders details of a national multimodal law for Cambodia and its accompanying regulations.



#### Second Expert Group Meeting on Finalisation of Implementation Framework for AFAMT

This expert working group for multimodal transport law, ie the ASEAN Framework Agreement on Multimodal Transport (AFAMT) 2005, held its second meeting from 26 to 29 August 2019 in Hoi An, Viet Nam at Hotel Royal Hoi. Assoc Prof Dr. Irwin UJ Ooi was tasked with speaking and leading the discussion on two key areas. First, The Benefits of Using AFAMT as Compared to Other Multimodal Regimes. Second, Designing an Insurance Liability Scheme for ASEAN Multimodal Transport Operators





### **Visiting Fellow Programme at Universitas Airlangga Surabaya Indonesia**

Under the Beyond Boundaries Law Programme, two of our lecturers, Puan Habibah Omar and Dr. Noraiza Abdul Rahman visited Universitas Airlangga (UNAIR) upon being appointed as Visiting Fellows of the University. The visit was made from 28 April-3 May 2019. They joined another fellow lecturer, Cik Mazlifah Mansoor who has been at Universitas Airlangga since 22 April 2019 on the same fellowship programme. These visits have provided excellent platform for academicians from both universities to discuss, share and strengthen mutual relation and at the same time discussing ventures for future collaboration. Puan Habibah gave public lectures to both undergraduate and postgraduate students in the area of Administrative Law and matters relating to government's accountability. Dr. Noraiza on the other hand, gave a lecture on research and legal methodology to the first and second year students of Universitas Airlangga .

### **Appointment as Malaysia's National Researcher**

Dr. Nadzriah Ahmad has been appointed as Malaysia's National Researcher to undertake a study for ASEAN International Commission on Human Rights (AICHR) entitled "Thematic Study on Juvenile Justice, With Particular Emphasis on Interrogation Practices for Children in Conflict with the Law". The study focuses on the interrogation practices for children in conflict with the law. Its objectives are to provide a comprehensive regional report on the practices and conduct of interrogation by officials toward children in conflict with the law (CICL) and to share/learn good practices on the same within the jurisdiction of ASEAN Member States (AMS). The study also aims to contribute to the promotion and protection of the rights of the child as enshrined in the ASEAN Human Rights Declaration (AHRD) and the UN Convention on the Rights of the Child (CRC).

### **Presentation to the National Children Council, Ministry of Women, Family and Community Development**

On 14 February 2019, Dr. Nadzriah Ahmad presented to the National Children Council, Ministry of Women, Family and Community Development on social issues among children and teenagers in Malaysia as well as making recommendations to the Ministry in order to afford better protection to children and teenagers in these three main settings; (a) healthcare; (b) safety and (c) education.

### **Moderator for the National Consultation for Mid Term Review (MTR) on ASEAN Regional Plan of Action on the Elimination of Violence against Children (ASEAN RPA-EVAC)**

On 18 February 2019, Dr. Nadzriah moderated the National Consultation for Mid Term Review on ASEAN Regional Plan of Action on the Elimination of Violence against Children (MTR ASEAN RPA-EVAC) in order to identify the developments, progress as well as challenges in the legal framework, prosecution and justice system. The MTR will take note of the latest progress in ASEAN Member States across sectors towards strengthening the response to violence against children. The analysis and findings will form a Regional Report. which will then be used to prepare for the 7th UN High-Level Political Forum on Sustainable Development (HLPF) in 2019 on the theme "Empowering people and ensuring inclusiveness and equality".



### **Meeting with Dr. Catherine Maternowska of the Global Partnership on Violence**

As one of the UNICEF Malaysia's partner, the UiTMLaw Child Law Centre has been invited to attend a meeting with Dr. Catherine Maternowska of the Global Partnership on Violence. Addressing Violence Against Children (VAC) will be the focus of the activities which will be conducted by the Child Law Centre in the coming year, in line with UNICEF's efforts towards implementing the Sustainable Development Goals on Violence with all child protection partners in Malaysia. In an effort to support this goal, UNICEF and other agencies developed the INSPIRE tool and resource package to guide their efforts. This meeting is part of the overall mission to provide platform with VAC partners to discuss Malaysia's role and contribution in ending violence, including potentially as a designated Pathfinder country.



### **Appointment as Exco Member for Selangor Malaysian Crime Prevention Foundation**

Dr. Nadzriah Ahmad has been appointed as the Exco Member for the Selangor Malaysian Crime Prevention Foundation (MCPF) on 16 July 2019 to lead crime prevention programmes in schools around Selangor among children and adolescents. MCPF recognised the importance of using schools as vital platforms to combat crimes and anti-social as well as delinquent behaviour among children in order to prevent them from coming into contact with the juvenile justice system.



### **Member of Consultation Session for Focus Group Discussion for Social Welfare Department, Ministry of Women, Family and Community Development**

Dr. Nadzriah Ahmad has been appointed as Member of Consultation Session for Focus Group on Advancing Child Well Being for the preparation of Strategic Paper for the 12th Malaysian Plan under the Technical Working Group for Community Development. The session took place on the 1 August 2019 where Dr. Nadzriah Ahmad presented and highlighted priority areas concerning children such as safety and legal framework and policies protecting children.



### **Assoc. Prof. Rohazar Wati Zuallcoble invited as a speaker at MyIPO Seminar ' Building Respect for Intellectual Property '**
