ABSTRACT

Zakat is a part of the pillar of Islam or specifically it is placed at third pillar of Islam which Muslim is obliged to pay zakat especially the one who are meet the requirement to pay zakat. Allah SWT obliged His servant to fulfil their responsibility as Muslim. Zakat can lead to a better socio-economic towards state and country which will help Muslim community to develop their quality of life. The purpose of this study to investigate the factors that motivate Muzakki to pay Zakat on Income with the target respondent at Tabung Haji Kuching.
