## ABSTRACT

## CHAPTER 1

### INTRODUCTION

#### 1.1 Introduction

Islam (الإسلام, *al-islām*), the youngest of the great religions is the world's second largest and arguably the fastest growing religion in the world. The word of 'Islam' can be defined as obedience or submission to God. (Mawdudi, 1980; Fowler, Gerber, Lawrence, 2000).<sup>1</sup> It is a monotheistic faith which refers believing the God (الله, Allāh) and one of the Abrahamic religions. Islam is a religion which guided by Prophet Muhammad who was the founder of Islam. Therefore, an adherent of Islam is called as 'Muslim'.

There are other world major religions such as Christianity, Baha'i, Buddhism, Confucianism, Hinduism, Jainism, Judaism, Shinto, Sikhism, Taoism, and Zoroastrianism. (Fowler, Gerber, Lawrence, 2000)<sup>2</sup> According to the 2010 World Muslim population statistic, the data shows that 69% of the world Muslim population is in Asia while 27% of it shows in Africa. (Kettani, 2010).<sup>3</sup> This statistic also showed in a survey done by Mehtab S. Karim(2010) titled 'Mapping the Global Muslim Population: Size and Distribution of the World's Muslim Population'.<sup>4</sup>
