ABSTRACT

This research mainly touches on the blasphemy laws in three different countries, namely Malaysia, the United Kingdom and Pakistan. Problems such as the setbacks faced in a Christian-dominated country such as the United Kingdom, the abuse and misuse of powers by the authorities in Pakistan, and the vague distinction between apostasy and blasphemy in Malaysia is discussed in this project paper.

Blasphemy has a close relation with freedom of speech and expression. Thus, this is also discussed thoroughly. We will later analyse whether blasphemy falls within the perimeters of the concept of freedom of speech and expression.
