## **ABSTRACT**

This research encompasses the study of law of citizenship in Malaysia specifically on the possibility of Malaysia granting dual nationality to the citizens. Malaysia has long implemented single nationality and this is entrenched in Article 24 of the Federal Constitution which deals with the termination of Malaysian citizenship in the event when a person acquired his second nationality. Not only that, Part III, Chapter 2 of the Federal Constitution further provides the provisions which states that dual citizenship is strictly prohibited in Malaysia.
