ABSTRACT

This project paper is a social-legal review and study on the rights of undocumented children in Malaysia. Undocumented children mean those who are without birth certificate or are unregistered with the National Registration Department of Malaysia. The focus is on the undocumented children of Malaysian parents which are deprived of their rights in their own country.

This project paper shall cover the rights of children governed by the 1989 United Nations Convention on the Rights of the Child (CRC) and several other laws in Malaysia, such as the Child Act 2001. Besides that, the study will be on the relevancy of reservations in certain Articles by Malaysia in the CRC and also the reasons for children being undocumented and its consequences.
