ABSTRACT

Jabatan Ketua Pengarah Tanah dan Galian (JKPTG) is one of the government organization to handle land cases which about Federal Land and Land Acquisition. Every end of year, discussion will be held between firm and those related to the land acquisition or federal land cases for compensation value. This discussion will be handled by top management. So, this research is about to study the factors that affecting the amount of compensation for land acquisition for federal projects.
