- ❖ To improve the quality of rural life through provision on upgrading the basic social amenities and facilities.

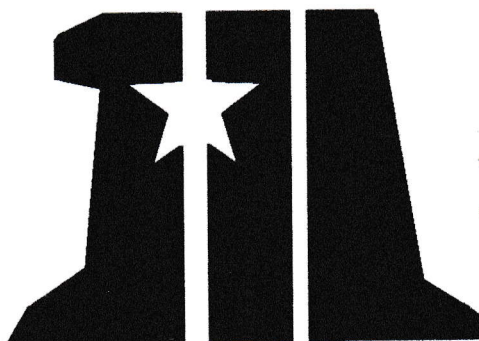
