There are two objectives of this study. First, is to analyze the problems and the performance of shipping service by the Shipping Department of Teledata Sdn. Bhd. (subsidiary of Sapura Holdings Sdn. Bhd.)

In analysing this, data were collected from the shipment report and documentations involve in the Shipping Department. Data were also obtained from the interviews that conducted to the Materials Management Division and Forwarding Agent staffs.
