ABSTRACT

The waqf properties in Malaysia is still in its initial stage. The establishment of the Selangor Waqf Corporation (PWS) has been a good start for a systematic management of warf. The purpose of this study is to look the perspectives of warf base on al-Quran and al-Hadith, analyse the development of waqf properties in Perbadanan Wakaf Selangor and to analyse the development of waqf properties through housing development project in Perbadanan Wakaf Selangor.
