ABSTRACT

Construction industry is one of the main industries in this country. The industry helps to generate the nation's economy as well as proving benefits to construction companies. But some of these firm acted unprofessionally by involving in project that do not meet the standart especially in housing development. There are a lot of defect to the houses purchase by house buyers especially in term of material and workmanship. This study has been conducted in the aim of identifying factors affecting quality of construction and type of defects. The methodology adopted was through literature review and interview the developer and the contractor. The result can show that poor workmanship is the major contributor to poor quality of construction. In order to minimize the problem, the contractor has to provide workers with necessary experience and skills. Generally, this practical training report clarifies the information about all of the repairing works, processes and methods during the building defect liability period (DLP).
