ABSTRACT

MoLAC application especially the Analyzer Module is the module of the application which was develop to analyze the performance of the children with the age between 3 to 6 years old especially in the knowledge of the basic knowledge that been included in the application by the Learning Module. By following SDLC (Software Development Life Cycle), the development of the application is succeeding according to all of the objectives and the scopes of the project that have been proposed.
