CHAPTER 1: INTRODUCTION

1.1 BACKGROUND OF RESEARCH

A novel coronavirus disease (COVID-19) that causes serious acute respiratory syndrome (SARS)-like symptoms was published in Wuhan, China, in November 2019. The epidemic was soon declared a pandemic, infecting millions of people and causing national locks in more than 180 countries (Johns Hopkins Coronavirus Resource Center 2020, n.d.). Malaysia was among the affected countries by the pandemic; the first wave of infection began on 24 January 2020 and the second one a month later. On 18 March 2020, the government placed a Movement Control Order (MCO), which put the nation on a partial lockdown. According to Wing Shin et al., (2020), The outbreak of the Covid-19 pandemic is first and foremost a human catastrophe in history, impacting hundreds of thousands of people across the globe.

Indirectly, it also has a growing influence on the global economy. Regulations forbid the boarding and disembarkation of passengers at all gateways, irrespective of ground, air or sea, except under some situations. Numerous transport hubs are seriously affected. It is of utmost importance that the government take the appropriate steps to slow down the spread of the Covid-19 outbreak, but this also ensures that students will miss classes worth at least a month. But Malaysians will not be the only ones affected by this global pandemic, as an estimated 1.25 billion students worldwide will suffer.

The Covid-19 epidemic affects all life sectors, including university classroom sessions worldwide. Therefore, the online learning approach is already an essential aspect for many universities to use. However not all educational institutions, particularly in under-resourced developed countries, have enough conditions, resources and expertise to conduct online learning (Lu et al., 2020).
