1.1 Background Of Study

For this selected project, Public Star Arena Sport Sdn Bhd is a one of famous sport center for futsal sport at Seremban, Negeri Sembilan is the chosen company. Previously, the place used as a futsal court was a manufacturing area. It is a factory building that has been used as a place for many teenagers in the local area to play futsal. Currently, it has four(4) existing courts that can be used. Its operating hours vary on weekdays and weekends. For weekdays the operating hours are from 3.00 pm to 12.00 pm, while on weekends it operates from 10.00 am to 12.00 pm. The futsal court is led by Public Star Arena Sport Sdn Bhd manager, Prasath Palan who is also the key person for the interview session in this project.

The current technology that Public Star Arena Sport Sdn Bhd used is the same as any other sports venues which still stick to the old methods. With the current system, users need to

call or come to the Public Star Court by themselves to check the availability of the court. After that, the staffs need to check the physical logbook to see the recorded booking data. If the court is available at the needed time, customers can proceed with their booking process and the staff will update the booking data in the logbook. However, if the court is not available or has been booked by other, the booking process will automatically terminate or rejected and the customer will given the choice to the booking to another date and time.
