1.0 INTRODUCTION

In this chapter, I am going to discuss about the background of the organization. Majlis Perbandaraan Johor Bahru Tengah (MPJBT) also known as Johor Bahru Tengah Municipal Council. The Johor Bahru Tengah Municipal Council is a local based council which was founded in 1953. It started as a small administration centre which eventually was merged to a Local Council, and once again, Johor Bahru Tengah has created another history when it was declared as a Local Authority with a Municipal status.

The rapid development of Johor Bahru Metropolitan has given a direct impact on Johor Bahru Tengah areas. Before it was given Municipal Council status, the total area was 303.5 km2. Initially after the status, the total area was 338.5 km2.
