CHAPTER 1 : INTRODUCTION

MARA Institute of Technology (ITM) is a statutory body governed by the Laws of Malaysia, Act 240. So, basically it is formed as part of government agencies.

ITM had designed their own financial system and its main function is to provide and supply information to aid/assist these following processes:

i) Financial Management Planning

ii) Implementing of Financial Service

iii) Controlling of Financial Activities

iv) Evaluating Financial Performance

ITM financial system involved all types of ITM funds and one of them is Management Fund. The activities included in this fund are budget, cash, supply and account management. Procurement is one of the activity carried out under supply management.

All types of procurement carried out by ITM should adhere to the rules and regulations provided under Treasury Instructions (No. 166 until 210), Financial Procedure Act 1957, Store Management Procedure and Treasury Circular which is circulated from time to time.
