On September 16, 1963 when Sarawak become one of the Malaysia state, Sarawak's Cooperative Development Department has become a federal matter and operates as one of the branches of Malaysia's Cooperative Development Department. This department was officially placed under the Ministry of Agriculture and Cooperative and the Ministry of National and Rural Development. The ministry was changed after the election in 1990 where Cooperative Development Department was then changed under the Ministry of Land and Cooperative Development. Not long after that, it was placed under the Ministry of Entrepreneur Development
