The centre was known as Pusat Latihan RIDA. RIDA +which acronym comes from Rural and Industrial Development Authority was establish to improve economic development as to give commercial training to rural local people. In November 1956, Dewan Latihan RIDA began its operation under its first principal Tuan Syed Alwi bin Syed Sheikh Alhadi. It was officially opened by Dr. Ismail bin Dato' Abdul Rahman, the Minister for Trade and Industry, on February 14, 1957.

In June 1956, a few proposals have been presented at the Bumiputeras Economic Congress. The proposal was to re-evaluate the objective of RIDA. After at passed, RIDA had made its steps by changing its name to MARA or Majlis Amanah Rakyat. Pusat Latihan RIDA changed to Maktab MARA in December 1965 after it passed by the parliament.
