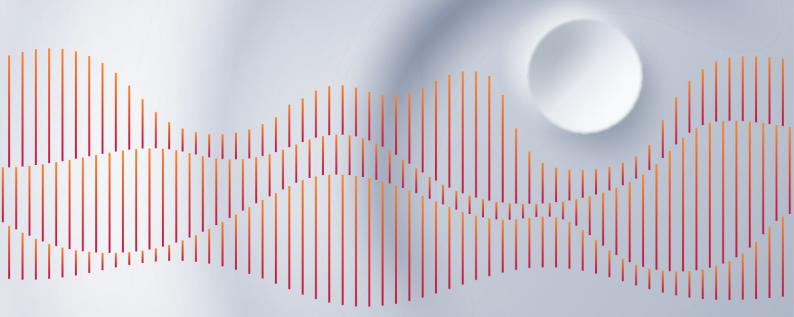

# **ABSTRACT**

Our product is a teaching aid about Faraid. Faraid is the name given to the Muslim law which determines the manner and order of distribution of the deceased Muslim's assets. Faraid is applied to the assets of a deceased Muslim which were not given away under the Will left by the deceased and which do not come within the description of any 'excluded assets' (I.R.B Law LLP, 2020). Our product can make it easier for others, especially students to understand how Faraid works. Many people though they know about Faraid but they do not care to practice this knowledge and cause quarrels among family heir. Not only that, the lack of understanding causes many people to not know how to solve problems about deceased Muslim assets (Abdul, Low & Partners, 2022). The Faraid Certificate can minimize the negative complications surrounding the distribution of estate from fraud or hiding from the entitled heirs, manipulation between heirs and their relatives as the certificate contains details of the heirs and the parts to be received which are valid by law (My Government, 2023). Although there are many guides on Faraid out there, it is mostly in a book form and it is hard to read and understand its content especially for elderly and beginner to understand. So in order to solve this problem and difficulty we invent this teaching aid which is a simplified version of Faraid knowledge that is easier to understand. This product is aimed especially for students and lecturers in school and



university. We are thinking of collaborating with Majlis Agama Islam because this product is under Islamic topics to get more accurate and detailed information.

#### **BACKGROUND**

Planning an estate entails deciding how to protect, manage, and distribute a person's assets after death. It also considers how someone would handle their assets and financial commitments if they become disabled. The distribution of wealth in accordance with one's goals and wishes after death is the last stage of preparation. Based on Faraid, this is done in compliance with Shariah laws. Writing a Wasiat, setting up a takaful trust, and estate distribution are all aspects of Islamic estate planning. Writing a will or splitting and disposing of a person's property after death in accordance with Sharia Law are both examples of Islamic estate planning.

Property encompasses both mobile and immovable items like money, takaful, insurance, shares, EPF, a house, a car, a plot of land, and other things. It is important to do estate planning because nowadays most people do not know about their estate planning. Therefore, we created a product that is a teaching aid about Faraid. This product came in a flash card form that can help in quickly memorizing and learning short facts, specific terms and the vocabularies.

Our focus on this product is to provide initial exposure as well as general knowledge about Faraid. Although there are many guides for Faraid out there, they are mostly in book form, and it is difficult to read and understand the content, especially for seniors and beginners. So, to solve these problems and difficulties, we created this teaching aid, which is a simple and compact version in Malay about the Faraid to be easier for students and the community to understand.

# PROBLEM STATEMENT

Many Malay and Muslim people are ignorant of Faraid and the distribution of property because they don't want to learn or aren't interested in these topics. The position of the heir and their connection to the deceased must be taken into consideration while distributing the estate of the deceased. Before handling the finances left by the deceased, the Muslim community has to understand this general information about inheritance distribution.

Other than that, there are many heirs out there and they frequently argue over who is entitled



to the inheritance and the property. However, they actually only receive a small portion of the money because they had no knowledge of Faraid's knowledge and it may result in conflict. The ability of the heirs to manage the inheritance with knowledge promotes family unity and well-being and demonstrates that Muslims are starting to apply great education.

## **OBJECTIVES**

The objective of the project we created is to increase Muslims' awareness of this Faraid and help them comprehend it better. The learning materials we provide will be geared towards university and high school students and will take the form of flashcards, making them portable and packed with Faraid information. This demonstrates the growing awareness among educators of the value of Faraid knowledge in the education of Muslims at all levels, including adolescents, adults, and senior citizens.

#### **NOVELTY**

A novelty in our product creation is a flashcard form about teaching aids in Faraid. The context in this flashcard is very simple and concise and easy to understand. Our product is the first version of a flash card design about estate planning designed by students of Universiti Teknologi Mara Melaka City Campus. It is provided for students and lecturers to help them in gaining general knowledge about Faraid.

Next, our purpose in creating this product is to increase knowledge about Faraid, which is Estate planning involves determining how individual assets will be preserved, managed and distributed after death. This knowledge is very important for their financial management in the future. Knowing the Faraid can be useful when making decisions on how to divide the deceased's property. For instance, under Faraid's supervision, each family member receives a share of every item left behind. As a result, the rightful party can claim any inherited property.

Lastly, our product also came in Malay to have a more understanding about the term used in Faraid. It also has Frequently Asked Questions in the back for easy reference and understanding of the differences between Faraid and other estate planning. This can help in educating readers to better understand the content of our products.

## **BENEFIT TO COMMUNITY**


