### 2.1 HISTORY OF THE SARAWAK TRANSPORT

#### **COMPANY (STC)**

Sarawak Transport Company has been established In 1952, during colonial time. It was still during the British government. Mr Chan Siaw Hee founded Sarawak Transport Company. During that time, every bus was only a small bus like a mini bus and used the wooden plan for the seat of the bus. During that time, the government found that, it was hard to manage a lot of buses in Kuching and for whole Sarawak. So, the Government asks the entire bus owner to cooperate in one association or one company. From that, Sarawak Transport Company and Chin Lian Liong were established. Both of this company will operate in within Kuching City.

Nowadays, Sarawak Transport Company has expanded their company to operate the bus services within the Kuching area and outside Kuching. Sarawak transport Company has their own definition about Bus Services in Kuching City. For them, as long as the buses are coming all the way inside Kuching, it will consider as services within Kuching City.

There are 240 buses provided by Sarawak Transport Company. 50 of the buses are operated in Kuching City such as Bau area, Batu Kawa, and so on. Sarawak
