### 1.1 Background of the study

### 2.1 Introduction

The claim that pairs of democracies are less likely to come into armed conflict with one another than the average pair of states is widely accepted in international relations. While there may be other explanations for the absence of connect amongst Western states, such as the adoption of liberal economic policies and membership in international governmental organizations, most scholars believe that democracy itself is an important force for peace.

One reason that scholars remain skeptical of attempts to dispute the empirical association between democracy and peace is that the theoretical explanations for why democracies ought to be less connect prone have proven quite fruitful, with many of their additional observable implications having been supported. The Vanhanen (1990) index defines democracy in terms of two vectors – the level of competition, in terms of number of parties, and the level of participation, in terms of turnout. Freedom House (2007) provides yearly measures of political rights and civil liberties since 1970. Finally, Przeworski et. al. (2000) utilize a binary measure of democracy from 1950 to 1990, *ACLP Regime Type*, indicating whether the party of power can lose office through elections. A score of 1 indicates authoritarian governance, and 0 indicates competitive elections. The inclusion of these alternative measures should reassure the reader that the findings are not overly influenced by the choice of measure, and will provide some interesting insights that will be developed below.
