3.3 Background

The history of the establishment of Pejabat Tanah dan Jajahan Pasir Mas is a development that held on a 107.06 acres of government land in Lubok Jong Mukim Apam, Gual Periok District. It is located along the Pasir Mas and Rantau Panjang highways. However, it was established on 1918 and the District Officer of Pejabat Tanah dan Jajahan Pasir Mas was Encik Jaafar. For now, Encik Hazmi Bin Abdul Hamid is currently the District Officer in which he began working for this department since 7 Mac 2021. The development component for Bandar Baru Pasir Mas also houses for the Pejabat Tanah dan Jajahan Pasir Mas building, Pasir Mas District Council, the Official Residence of the District Chief and the Multipurpose Hall. Jajahan Pasir Mas is centered in Pejabat Tanah dan Jajahan Pasir Mas in which it is under the administration of State Secretary. Pejabat Tanah dan Jajahan Pasir Mas offers services to 10 districts in which it is under the administration of Pasir Mas District that includes 40 Land Sub-Districts and 83 Penghulu Sub-Districts. For Penggawa District, it consists of Alor Pasir, Bunut Susu, Chetok, Gual Periok, Kangkong, Kubang Gadong, Kubang Sepat, Lemal, Pasir Mas and Rantau Panjang districts. However, Pasir Mas district occupies 614.15 square kilometres, or 57,800 hectares, which is 3.9 percent of the area of Kelantan.
