

# COMPANY'S PROFILE <sup>99</sup>

The Pendang District Council, or Majlis Daerah Pendang, was formerly known as the Pendang Town Board (Lembaga Bandaran Pendang), which was administered by the Setar Town Board. On January 1, 1976, Pendang Town Council was detached from Kota Setar Town Council and established its own administrative and service area, which includes Pendang Town, Bukit Jenun Town, and Tokai Town and spans an area of 6,825 km<sup>2</sup>. From

March 1, 1979. The Pendang Town Council was renamed the Pendang Local Government District Council, and after its inception, the Pendang Local Government District Council gazetted its administrative territory, which included the whole Pendang District and was 629.29 km<sup>2</sup>. Since 1987, with the consent of the State Government to standardise the titles of Local Authorities across the nation, the Local Government District Council has been known as the Pendang District Council.



Majlis Daerah Pendang's building was situated at Wisma MDP, 06700 Pendang, Kedah Darul Aman. It consists of three levels, eight managements, and four units. Management Services Department (Human Resource Department, Administration Department, and ICT Department), Finance Department, Property Valuation and Management Department, Engineering Department, Department of Development Planning, Department of Health and Environment/Licensing, Enforcement Department, Community Development Department, Legal Unit, Internal Audit Unit, Corporate Communications and Public Relations Unit, and OSC Units are a few examples.
