#### 1.6. Introduction

Disabled person means "Persons who have a physical or mental impairment that substantially limits one or more major life activities" (West's Encyclopedia of American Law, 2006).

Our prime minister Dato Seri Mohd Najib B. Tun Haji Abdul Razak also announced "All public building and amenities must be disabled friendly" (The Nut Graph, Ding Jo-Ann, 19 Feb 2010). However, in currently situation some parties are not showing their responsibility in administer the facilities for disabled person. Malaysia government also prepared act for disabled person such as Person With Disable Act (PWDA, 2008) and certain part in Uniform Building By Law (UBBL, 1990) but until now how long involved parties follow the act in design public building.

According to the statistics provided by the World Health Organisation (WHO), it is estimated that 5–10% (1.3–2.6 million) of the world's population are Person With Disabilities Act (PWDs). As reported by the Department of Statistics Malaysia, the total population of Malaysia in 2006 was 26.64 million people. Of the total population, 1.3–2.6 million are PWDs. However, as of December 2007, only 220 to 250 PWDs were registered with the Social Welfare Department.
