### **3.2 MISSION**

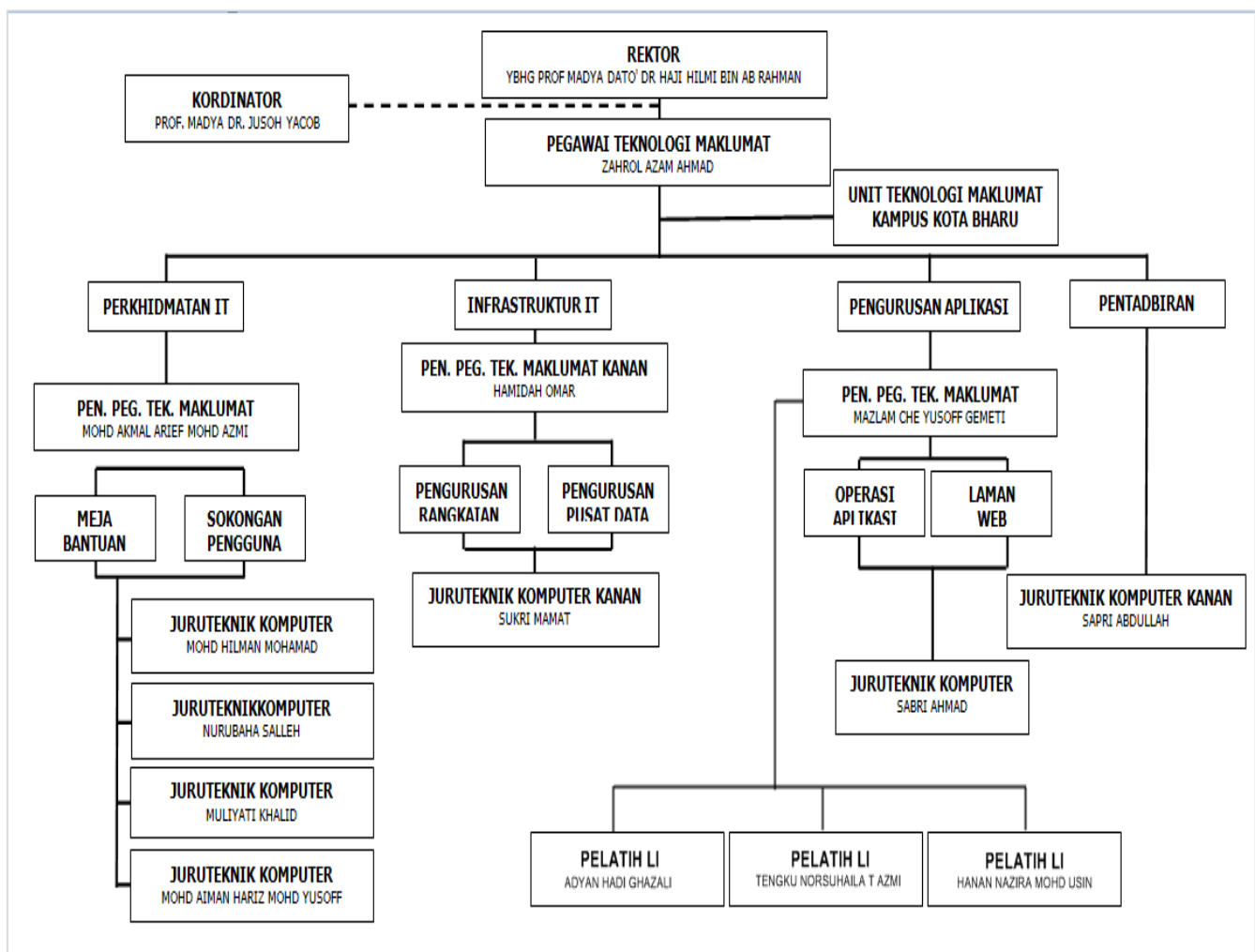
Application, strengthening the use of ICT Technology Enhancement and through infrastructure development, learning, teaching and assimilation of ICT in academic staff and administration.
