2.0 COMPANY'S PROFILE



Founded in 1981, the facility in Kedah is strategically located to serve both domestic and international markets. Petronas Chemicals Fertiliser Kedah Sdn. Bhd. produces fertilizers in Malaysia. The Company (PC FK) is a Malaysian urea production company and a wholly-owned subsidiary of Petronas. As part of the Petrochemical Division of the Malaysian oil giant PETRONAS, the Company's primary product is granular urea, with ammonia and methanol as secondary by-products of the manufacturing process. Currently, the plant has a rated urea output of 2100 MT per day.

The production of further secondary petrochemicals, including plastics, glue, synthetic fiber, synthetic rubber, and lubricants, also uses the company's urea product. The majority of the Company's products ship through a deep arrive export terminal in Butterworth, Penang, which is connected to the main production plant by train. MITCO Sdn Bhd, PETRONAS's marketing arm, is responsible for marketing the majority of the Company's products. The business is based in Gurun, Kedah, Malaysia, and was established in 1983.
