1.0 ABSTRACT

2.0 INTRODUCTION

With the increasing aspect of technological features nowadays, an extensive literature has developed on the pirating of audio-visual products, which discussed the threat to the western cultural industries. Although pirating of audio-visual products tend to be viewed more as a 'criminal' activity, both of the article take a different aspects of the means and consider the major social, economic and political factors behind the extent of this phenomenon as well as the way the latter try to respond to the former. The earlier article of Mattelart analyze some of the underground channels through which cultural globalization is operating, while the later one are more focused on the issues raised by physical piracy in the countries of the south and the east of America.
