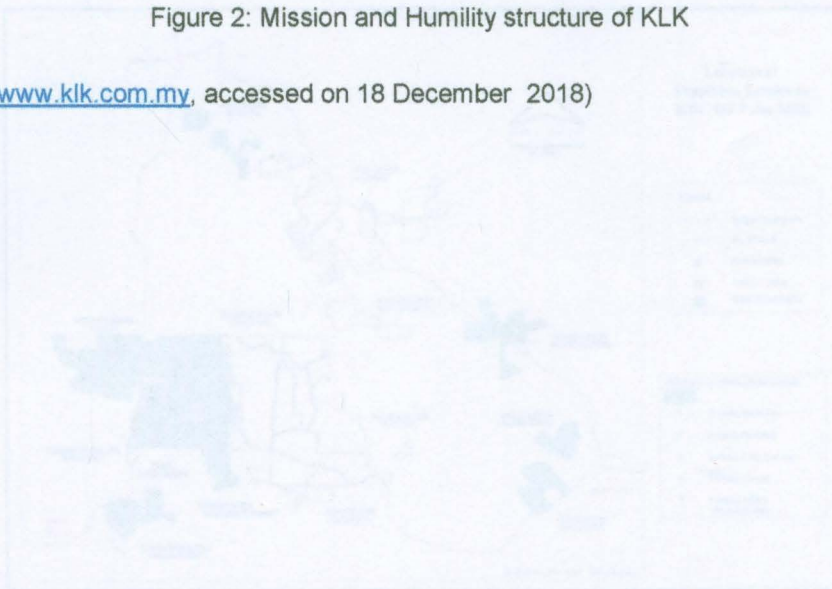


Figure 4. Field Map of Sri Kundh Estate
