ABSTRACT

This study reveals the analysis of financial performance for SCOPE INTERNATIONAL (M) SDN BHD from year 2004 to year 2008. Scope International (Standard Chartered Operation are wholly owned subsidiary by Standard Chartered Bank. August 2002, SCOPE INTERNATIONAL (M) SDN BHD was established to design, develop, and implement to support Wholesale Banking operation of SCB. The objectives the studies are to investigate which year is more profitable for the company and to identify the flow of the performance by the company during the year studied. To analyze this company's financial performance, financial ratios and common-size analysis were used and calculated based on the information disclosed on the financial statement of the companies. The study identifies the financial strength on certain criteria. Five types of ratios were selected and constructed.
