#### Abstract

An orphanage home is a residential institution devoted to the care and education of orphans. Orphan homes provide an alternative to foster care or adoption by giving orphans a community-based setting in which they live and learn. Many of orphanage homes are not properly well managed and lack of facilities and equipments. Most of homes have a low level of effectiveness in facilities.
