INTRODUCTION.

Purpose.

The purpose of this paper is to make a modest attempt to present the difficulty in determining whether one is a Malay or not if the definition of Article 160 (2) is to be the test. The difficulty may arise in the granting of the special privileges of the Malays.

It is firstly submitted that it is never intended to be argued whether the Malays have the right to the special privileges or not as these rights are unambigiously laid down in Federal Constitution.

Scope.

The 'Malays' discussed in this paper is confined to the Malays in Peninsula Malaysia only so as to keep the project paper from covering too wide an area.

Methodology.

This paper discusses the literal interpretation of article 160 (2) which states inter alia, that a " Malay " means a person who professes the religion of Islam, habitually speaks the Malay language and conforms to Malay custom.

Researches on the Malay language and custom was made mostly in the Perpustakaan Tun Abdul Razak, I.T.M. and Perpustakaan Negara Malaysia, Kuala Lumpur.

Interviews were held with officials from the Amanah Saham Nasional and Mara Institute of Technology, 2 bodies that are part of the special privileges of the Malays.
