ABSTRACT

This research analyzed on the different features of the Malaysian Anti-Corruption Commission (MACC) with the Independent Commission Against Corruption (ICAC), Hong Kong. The differences were scrutinized to identify whether such differences of the features contribute to the efficiency and effectiveness of the MACC. Based on the differences identified, some recommendations were made with the intention to improve the efficiency and effectiveness of the MACC.
