## **Abstract**

This research paper of comparative study between the United States, Iran and Malaysia on the program of condoms and needles distribution in controlling HIV/AIDS started out with the main objective as to study whether the scheme is the best and had effectively achieved its aim. It looks at the different approaches that each country had to the implementation of the program; the liberalism of the States, the restrictive approach of the Islamic country, and the justification that each country had to establish such scheme.
