ABSTRACT

Our main research deals with how Polygamy is affecting Muslim women in a multicultural society in Malaysia. We do our research by focusing on the Muslim Family Law, a law that only applies to Muslims. We will look at the complexities of implementing a law based on the *Qur'an* in a modern multicultural society. Dealing with the complexities means touching upon or going into detail about subjects such as human rights, modernisation, patriarchy and identity. The aim is to understand the contemporary debate about the Polygamy by interviewing people in the debate and ask them to think about, what are the problems? What causes these problems?
