and ability towards the community participation in protecting heritage site in Lembah Bujang.

Gelam in Mukim Bujang. The respondents were selected to fill the set of guestionnaire

consist of 5 sections which are Demographic Information (Section A), Community

Participation in protecting heritage site (Section B), Motivation (Section C), Opportunity

(Section D) and Ability (Section D). The data was analyzed with Descriptive Statistic,

Pearson Correlation and Multiple Regression using the Statistical Package for Social

Sciences (SPSS) version 23. The result indicates that there were significant relationship

motivation, opportunity, and ability towards the community participation in protecting heritage

and create awareness among the community in order to encourage the community to

participate in protecting the heritage site.
