## 1.2 EXECUTIVE SUMMARY

MEIDO KISSA TECHNOLOUNGE is a café establishment that aims to provide the best hangout spot and lounge in Malaysia which uses technological approach to delight and attract customers, and at the same time keeping it distinguishable and unique from other competitors in the market. Thus MEIDO KISSA is a new venture for Technological Entrepreneurship in Malaysia.

The main selling points for MEIDO KISSA would be the hi-tech equipments that will be prepared for the user at the café.
