ABSTRACT

This research presents a study that focusing on interdependency of determinants of capital structure in technological sector firms listed in Bursa Malaysia. Capital structure is playing an important role in the companies. In addition, capital is the primary resources for the firms and they can be from debt and also equity. The determinants were chosen based on suitability of the research. The independent variables are long term debt, short term debt, total debt, tangibility and firm size whereas the dependent variable is return on equity. This research utilizes a panel data which are from 2012-2017 for six years and different eleven firms in technological sector. The sample in this study are collected from financial reports in Bursa Malaysia website only. All the data are based on the Malaysian Ringgit (MYR) unit.
