



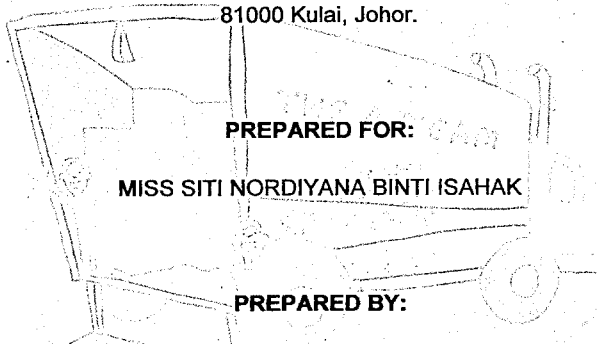

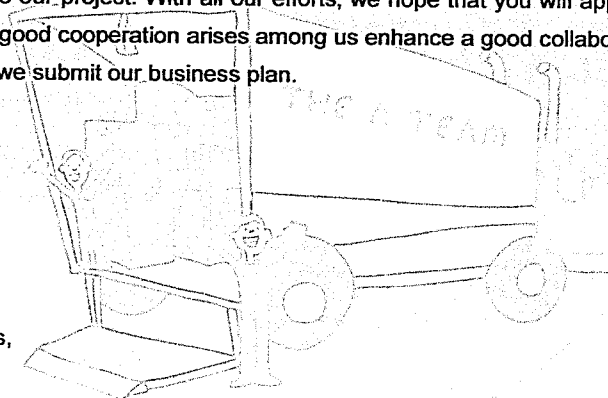

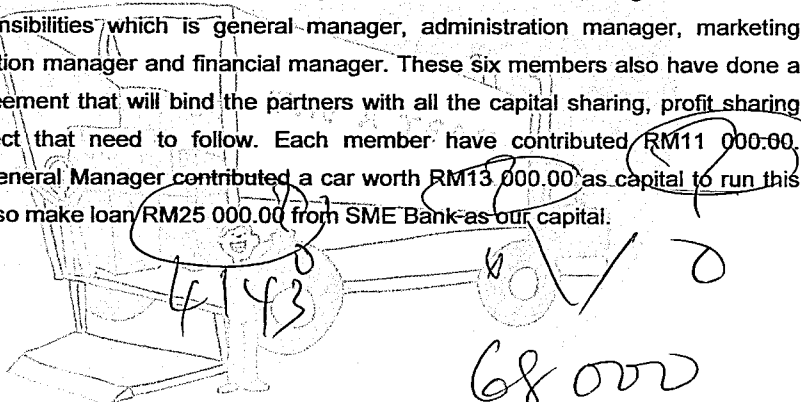
EXECUTIVE SUMMARY

The A Team is a customer service based business that located at No. 4, Persiaran Indahpura Utama, 81000 Kulai, Johor.

The A Team is a business that provides moving service. We conduct residential and commercial moving from Kulai, Johor and the surrounding area to any district in Johor. In the same token, we offer two types of services which are Full Service and Individual Service which consist of pack and unpack customers' goods and lorry rental service.

A lot of people tied with many commitment which means moving to a new location can be extremely stressful. We dedicate this moving service for people who want a stress-free moving process. They no longer have to worry their goods as we provide pack and unpack goods service. Besides, they do not have to worry about travelling back and forth to shift their goods to a new location as we provide lorry rental service based on per hour basis.
