ABSTRACT

Kuala Lumpur International Airport is Malaysia's major and largest airport. KLIA has the largest number of airside vehicle compared with other airport in Malaysia. KLIA is facing airside vehicle operation issues since the increases in airport traffic and airside vehicle activities. This has resulted in problems leading to delays and inadequate infrastructure. It is the objective of this study to determine airside vehicle operation problem on the apron, taxiway and other aircraft movement area at KLIA.
